RULES AND REGULATIONS

The following constitute the rules and regulations governing the exhibits under the auspices of the Buckeye Area Chapter of AAMT and are part of the exhibit contract as incorporated therein.

PAYMENT

Payment in full must accompany the application and contract. **DEADLINE DATE FOR EARLY PAYMENT is July 15, 2006** (postmark date). Regular rate is in effect after July 15, 2006 (postmark date).

ANNUAL MEETING AND EDUCATIONAL CONFERENCE HOTEL

The headquarters of the 2006 BAC Symposium, "Transcription Takes Flight" is the Hope Hotel & Conference Center, Wright-Patterson Air Force Base, WPAFB, Ohio . Requests for accommodations will be handled by the Hope Hotel & Convention Center at 937-979-2696. Ask for the reservationist and request the special group rate per night for the Buckeye Area Chapter Symposium. Reservations may also be made at www.hopehotel.com. The room rate is \$70 per night for 2 adults (each additional adult is \$10/night extra) plus 10% tax (single/double – each room is a suite equipped with refrigerator). **DEADLINE FOR HOTEL ROOM RESERVATIONS IS AUGUST 15, 2006.** Rooms are limited and are on first come/first served basis.

USE OF EXHIBIT SPACE

Exhibits will be confined to the specific limitations of their respective contracted space(s). No interference of normal traffic flow or infringement on neighboring exhibits is permitted. Any such interference shall be deemed a breach of this contract if same is not resolved immediately upon notification of said interference.

ELECTRICAL

Any/all exhibitors who need electrical outlets in their exhibit space will make arrangements with the exhibit chairperson prior to this event. Please let us know your requirements as soon as possible to make sure we have these services available at your exhibit site. Each exhibitor is responsible for supplying any needed extension cords and/or power plug strips as needed by your exhibit. Outlets may not be directly next to your booth area.

LOCAL REGULATIONS

All materials and equipment must conform to all applicable Federal, State and Local building, electrical, fire and related safety regulations. It is the responsibility of the exhibitor to assure compliance with said applicable regulations.

SUPERVISION OF EXHIBIT SPACE

The exhibitor shall provide staffing of exhibit space through the exhibit dates and hours and shall at no time during the date and hours permit the exhibit space to be unattended. In the event that said exhibit space is left unattended after notification of same, the exhibitor shall be deemed to be in breach of this contract and BAC may dismantle said exhibit at the expense of said exhibitor.

INSURANCE

Neither the Hope Hotel & Conference Center nor BAC maintains insurance covering property brought onto the hotel or convention center premises by exhibitors, and it is the sole responsibility of the exhibitor

to obtain insurance covering such property. BAC is also not responsible for the personal property of the exhibitor, which is not associated with the exhibit itself.

FAILURE TO OCCUPY SPACE

Any exhibit space not occupied by 7:30 a.m., Saturday, September 16, 2006, may be canceled or reassigned without any obligation on the part of BAC for any refund whatsoever. BAC shall also not be responsible for providing alternate exhibit space in the event of cancellation or reassignment.

REMOVAL OF EXHIBITS

Exhibits may not be dismantled before 3:30 p.m., on Saturday, September 16, 2006. Exhibits must be removed from the exhibit hall by 4:00 p.m.

EXHIBIT SETUP

Exhibits may be set up between 6:30 a.m. and 7:00 a.m. on Saturday, September 16, 2006, and opened from 7:00 a.m. until 3:45 p.m.
