Directions to:

At City of Mason Municipal Building

6000 Mason-Montgomery Road, Mason, Ohio 45040 Room 2029, 2nd Floor Park in Lot in front of the City Building

From North or South I-75 from, Exit 22, which is Tylersville Road, West Chester, Ohio

From the North traveling Southbound I-75

Turn left at the ramp off of I-75, and you will be then traveling East on Tylersville Road. You would follow Tylersville Road until the intersection of Mason-Montgomery Road (see attached map). Turn left onto Mason-Montgomery RD, following Mason-Montgomery Road north to the intersection of Foxfield Drive. Turn right onto Foxfield Drive (the municipal building is about 4 miles from I-75).

From the South traveling Northbound I-75

Turn right at the ramp off of I-75, you will be then traveling East on Tylersville Road. You would follow Tylersville Road until the intersection of Mason-Montgomery Road (see attached map). Turn left onto Mason-Montgomery RD, following Mason-Montgomery Road north to the intersection of Foxfield Drive. Turn right onto Foxfield Drive (the municipal building is about 4 miles from I-75).


From the North traveling Southbound I-71, Exit 25, Kings Mill RD (North of Mason/Kings Mills) Turn right onto Kings Mills Road, follow Kings Mills Road (twists and turns past The Beach and the former Jack Nicholas Golf Course) until you get to the traffic light at the intersection of Main ST/US 42/Reading RD & Kings Mills RD. Turn left onto Main ST/US 42/Reading RD. Follow to the first traffic light, turn left onto Mason-Montgomery RD. Stay in left lane, the first traffic light on Mason-Montgomery RD is Foxfield Drive, turn left onto Foxfield DR.

<u>From the South traveling Northbound I-71</u>, Exit 24, <u>Western Row RD</u> (exit for Kings Island) Turn left onto Western Row RD, follow this (changes into Tylersville Road a few lights off of I-71). Follow this to the intersection of Tylersville RD & Mason-Montgomery RD. Turn right onto Mason-Montgomery RD. Follow to the intersection of Mason-Montgomery RD & Foxfield DR. Turn right onto Foxfield DR.

On Foxfield Drive – from all directions go to the second drive on the right (just past the police department entrance) and you will see a sign City of Mason, for court/municipal building. Enter the doors just to the left of the city courts. Take the elevator to the second floor to room 2029.
